2. The applicants who have submitted application for the above pensions/allowances to the department and is pending may also attend the camp along with the documents mentioned above.


3. The Transgender persons or their parents/releative if any; within the locality may also attend the camp for obtaining detail information from the officials to avail the benefits already notified by the Government.

4. The Government has notified the scheme called "GRANT OF AWARD OF MARRIAGES WITH DISABLED PERSONS". The individual(s) are also advised to attend the camp for obtaining detail information from the officials to avail the benefit.

**5. All the Beneficiaries should submit their documents personally or through their Ward Panchayat or their near relative(s) compulsorily during the camp else their name shall be deleted from the Departmental Database and no request whatsoever shall be entertained for re-inclusion of their names for drawl of pension/allowances.**

The District Collectors, Municipal Commissioner, Additional District Collectors (Development), Sub Divisional Magistrates, Gram Vikash Adhikaris, Panchayat Members, Teachers, Self Help Groups, ICDS Supervisors , Anganwadi Workers, Health Workers and well wishers are requested to kindly convey the above information to the beneficiaries and request them to attend the camps at designated Gram Vikash Kendras with the documents mentioned above .

This Notice is issued in the public interest with a view to update the Data base of the Department as a part of Annual Verification of particulars to effect correct transfer of pension in the accounts of the individual beneficiaries well in time. The beneficiaries are also advised to open Bank account with any nearest Nationalized Bank under the Prime Minister's Jan Dhan Yojana. The system of opening Joint account is ordinarily discouraged to prevent misuse of pension as the scheme is meant for beneficiaries only.
