2. TERMS OF REFERENCE:-

The terms and reference of the Committee shall be as under, namely:-

The Committee shall review and coordinate the activities of all Departments of State Government and other Governmental and Non-Governmental Organizations dealing with matters relating to Persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities pertaining to the following schemes and programmes, namely:-

- (1) ARUNIM – Association for Rehabilitation under National Trust Initiative of Marketing.
- (2) Aspiration- This is an early intervention training programme also known as school readiness programme for children upto 6 years of age with development disabilities.
- (3) Badhte Kadam-A Pan India Awareness Campaign undertaken by National Trust.
- (4) GHARAUNDA-Group Home and Rehabilitation Activities under National Trust Act for Adults with Development disabilities.
- (5) Gyan Prabha- Scholarship scheme for pursuing post schooling, any vocational training professional courses including graduation and post graduation for enhancement of skill.
- (6) Innovative scheme- to encourage bright, new ideas such sensory park, alternative augmentative communication (AAC) devices etc.
- (7) Niramaya Health Insurance Scheme.
- (8) Sahyogi-Caregivers training and deployment scheme.
- (9) Sambhav- A National Resource Centre for assistive devices.
- (10) State Nodal Agency Centre.
- (11) Uddyam Prabha.
- (12) Early Intervention- in partnership with the RBSK Scheme at state level.


