**NOTICE**

The Department has released the pensions for the months of **December, 2016 to March, 2017** of all beneficiaries drawing pensions/ allowances under the following schemes in the respective Banks

1. Indira Gandhi National Old Age Pension
2. Indira Gandhi National Disability Pension
3. Indira Gandhi National Widow Pension
4. Unmarried Women Pension
5. Subsistence Allowance
6. National Family Benefit Scheme

The beneficiaries are advised to collect the pension from their Banks duly producing the Pension Passbook in original issued by the Department along with the Bank/Post Office Passbook. In case, the Pensioner(s) are differently abled and old aged, the legal heir may draw the pension from the Bank by submitting the Authorization letter from the Pensioner duly certified by the Ward Panchayat and authenticated by the Sub-Divisional Magistrate or the Gram Vikash Adhikari /Block Development Officer as the case may be.

**Efforts may be made by all Branch Managers to disburse the Pensions within a period of one month failing which the undisbursed sum may be refunded to the Department along with the beneficiaries Bank and Scheme details. This may be brought to the notice of all concerned through local support.**

Further, all the Panchayat members in rural areas and Councilors in urban areas are requested to report the death of beneficiaries along with their death certificates, if any, under their respective units/ wards to the Social Justice, Empowerment & Welfare Department on month to month basis in future to enable us to update the database on regular intervals.

The Ministry of Rural Development vide Notification No: S.O. 641(E) dated: 27<sup>th</sup> February 2017 has mandated the submission of Aadhaar Number by all the beneficiaries desirous of receiving benefit under the National Social Assistance Programme . Beneficiaries who have not yet enrolled for Aadhaar Number are requested to do so at their nearest Aadhaar Enrollment Center and submit their Aadhaar Number and Aadhaar Consent Form to the Department at the earliest.

**The beneficiaries residing within the Gangtok Municipal Corporation are requested to kindly attend the office of the Additional Secretary, Social Welfare Division, 5<sup>th</sup> Mile Tadong personally alongwith Aadhaar Card, Bank Account Passbook, Ration Card to fill up the Aadhaar Consent Form if not already filled up through the Resource Teacher, Sarva Siksha Abhiyan and RDAs/PDAs of the Rural Management Development Department during office hours from 01.05.2017 in accordance with the notice published in Samaj Dainik and Sikkim Reporter dated: 15.03.2017 and 16.03.2017 respectively.**
